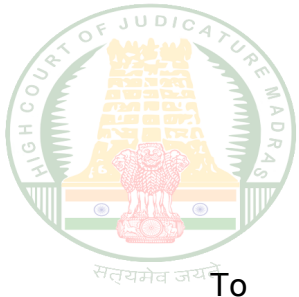
2.Mr.J.Ashok, learned Additional Government Pleader for the respondents has no objection to the prayer made by the learned Counsel for the petitioner.
