ORDER

Mr.K.Ramaiah, learned Standing Counsel takes notice on behalf of the respondents.

2. The present writ petition has been filed by a retired employee of the respondent transport corporation, seeking a mandamus to disburse the surrender leave salary along with interest.

3. A perusal of the records reveals that the petitioner who was working as a conductor in the respondent transport corporation had attained superannuation on 30.04.2015. However, surrender leave salary was not disbursed to him at the time of retirement. Hence, the petitioner has sent a representation on 18.12.2024, seeking the above said benefits. Since there is no response, the present writ petition has been filed.

4. Considering the said facts, the respondents are directed to disburse the eligible surrender leave along with 6% interest from the due date till the date of disbursement within a period of two (2) weeks from the date of receipt of a copy of this order.
