2. The learned Government Advocate for the petitioners submitted that a sum of Rs.20,00,000/- has already been settled towards Death-Cum-Retirement Gratuity, but the same has been suppressed.

3. All that has been ordered in the Writ Petition is to settle the said amount along with interest. At the time when the Writ Petition was heard, there was no representation to the effect that the above benefit has already been paid. If the petitioners claim that the said sum has already been settled, the relevant records may be produced during the contempt proceedings, if any, initiated by the petitioner in the Writ Petition for non-compliance of the order.
