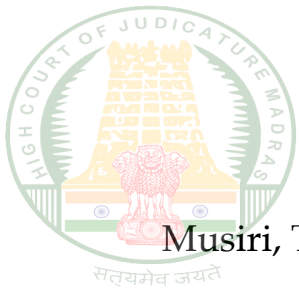

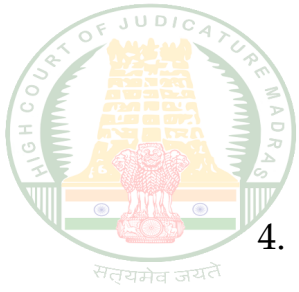
JUDGMENT

This writ appeal is filed against the order dated 10.01.2025 made in W.P(MD)No.26192 of 2024.

2. On the earlier occasion, when we expressed our disinclination to entertain the writ appeal, the appellant sought time to file an undertaking affidavit to indicate when he would vacate the subject premises.

3. Today, the appellant has filed an affidavit seeking three months time to vacate the subject premises.
