PRAYER: Writ Petition filed under Article 226 of the Constitution of India, to issue a Writ of Mandamus, directing the fifth respondent's Company (MITPL) to pay compensation amount of Rs.5,00,000/- (Rupees Five Lakhs only) and consequently, direct to build the southern side compound wall of the 5th respondent's Company to prevent further damage by flow of drainage effluence into the petitioner's agricultural land.
