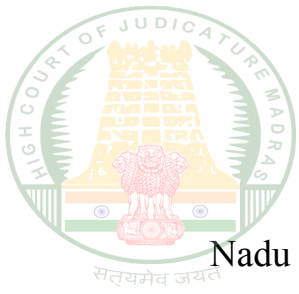

ORDER

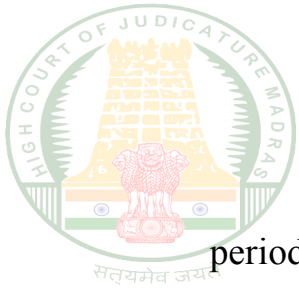
(Order of the Court was made by **G.R.SWAMINATHAN, J.**)

3. The third respondent is directed to submit the necessary proposal to the jurisdictional DIG within a period of four weeks from the date of receipt of a copy of this order. The jurisdictional DIG in turn shall process the same and forward it to the first respondent within a

period of two weeks thereafter. The first respondent will pass an order on merits and in accordance with law within a period of 8 weeks thereafter. We have not gone into the merits of the matter.
