2. According to the revision petitioner, the revision petitioner filed the suit in O.S.No.333 of 2024 for recovery of money from the respondent herein. Subsequently, he filed a petition in I.A.No.2 of 2024 for attachment before judgment under Order XXXVIII, Rule 5 of the Civil Procedure Code, 1908 and the respondent also filed his counter. When the case came up for hearing on 07.01.2025, it was adjourned to 01.04.2025 for the respondent's side enquiry and the same is still pending and there is no other interlocutory application pending in the suit.
