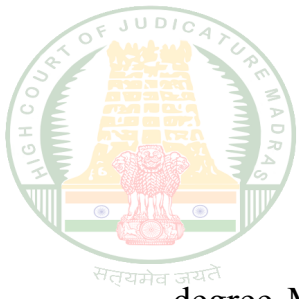

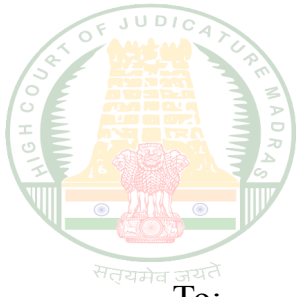
2. In view of the letter dated 15.04.2025 and the endorsement made by the learned counsel for the petitioner, this Writ Petition is dismissed as withdrawn.
