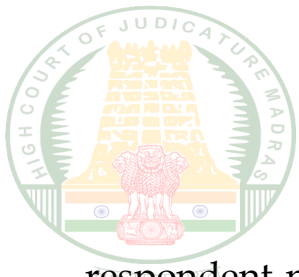

To this effect, this petition is ordered.
