Seeking to quash the First Information Report in Crime No.243 of 2023 on the file of the first respondent police, this Criminal Original Petition has been filed.

2. Heard the learned counsel appearing on either side and perused the materials available on record.

3. The matter pertains to a matrimonial dispute between the de-facto complainant, who is the wife of one Nithyanantham, the son of the first and second petitioners.

The learned counsel for the petitioners submitted that a compromise has already been arrived at between the parties and that the second respondent, Karthika, is living happily with her husband in a separate residence.
