ORDER

The petitioner has filed this petition to direct the first respondent to contrast the second respondent not to harass the petitioner under the guise of enquiry based on the petitioner's representation dated 20.01.2025.

2.The contention of the petitioner is that there is property dispute between the petitioners and the third respondent, who had given a complaint before respondent police. Under the guise of enquiry, the respondent police is harassing the petitioners.
