WEB COPY This criminal original petition has been filed by the petitioner to quash the F.I.R in Crime No.39 of 2024 on the file of the first respondent police.

2. According to the petitioner, he is a teacher working in School. While so, a false complaint has been lodged against the petitioner and the respondent police has also registered the false complaint in Crime No.39 of 2024 for the offences under Sections 11(1), 12 of Protection of Child from Sexual Offences Act, 2012 and 296(b) of BNS, 2023. In fact, no occurrence was happened and even as per the F.I.R, there are no ingredients to constitute the offence. Therefore, the pending F.I.R is liable to be quashed.
