ORDER

Heard the learned counsel on either side.

2.During the course of the arguments, it is brought to my notice that at the instance of the ninth respondent, this Court in W.P(MD)No.1758 of 2025 has set aside the very same impugned order, which is under challenge in the present proceedings, and the matter has been remitted to the first respondent for conducting fresh enquiry. In the said order, this Court directed the first respondent to hear not only the petitioner, who is the ninth respondent herein, but also all interested persons and their objections. Therefore, this writ petition is allowed and the impugned order Ni.Mu.No.849907/2023/G5, dated 19.12.2024 passed by the first respondent, is set aside. The parties in the present writ petition are at liberty to agitate all their rights, claims and contentions and make all objections before the first respondent, who has been directed to hear all interested
