The said representation was received by the respondents 1 & 2. The first respondent has sent a reply on 22.10.2024

Dissatisfied with the said reply, the present writ petition has been filed. Insofar as, the documents are concerned, the register, which are available with the Sub-Registrar, the petitioner it is always open to obtain a certified copy of the same.

5. Insofar as the request for survey in the property and demarcating the boundaries of the schedule B property namely, the undivided half share in the 67 acres 95 cents in S.No.592, New Survey No.2681/1A situated at Vilpatti Village, Kodaikanal Taluk, Madhura District, the petitioner can make an application after paying the necessary charges and there upon, the second respondent, subject to appropriate application being made along with necessary enclosures, shall act on the application made and dispose of the same, within a period of twelve (12) weeks thereafter.
