This petition has been filed praying to direct the third respondent to file the final report in Crime No.200 of 2024 on the file of the third respondent police.

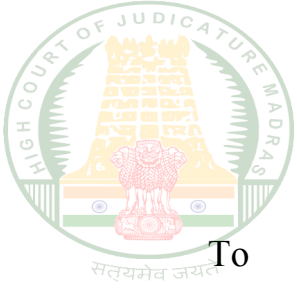
2. Heard the learned counsel appearing for the petitioner and the learned Additional Public Prosecutor appearing for the respondent.
