Without expressing any opinion on merits of the writ petition, the fourth respondent is directed to permit the petitioner to verify the 'A' Account Book alone for the relevant period in which the document said to have been registered in respect of the subject property and pass orders on merits and in accordance with law within a period of two weeks from the date of receipt of a copy of this order.

4. With the above direction, the writ petition is disposed of. No costs.
