(Order of the Court was made by J.NISHA BANU, J.)

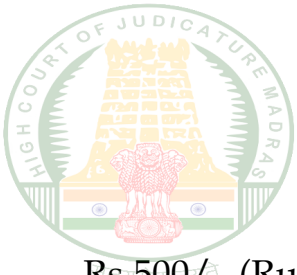
This petition is filed to condone the delay of 166 days in filing the above Writ Appeal.
