The learned Additional Government Pleader also submits that the authorities will not venture to carry out any mutation pending disposal of the appeal suit in A.S.No.49 of 2024 before the Sub-Court, Aruppukottai.

5. Recording the said submission of the learned Additional Additional Government Pleader, no positive orders are required in this writ petition and hence, this writ petition is disposed of. No costs. Consequently, connected miscellaneous petition is closed.
