ORDER

The instant writ petition has been filed by Junior Assistant (under suspension) working in the Town Panchayat Department, seeking a mandamus to revoke the order of suspension dated 05.07.2024.

2. It could be seen from the records that the petitioner was placed under suspension pursuant to his implication in a criminal case in Crime No.15 of 2024 for the offences punishable under Section 7(A) of Prevention of Corruption Act, 2018. The petitioner has been issued with a order of suspension on 05.07.2024. The petitioner has given a representation on 11.09.2024, seeking revocation of order of suspension, to the first respondent.
