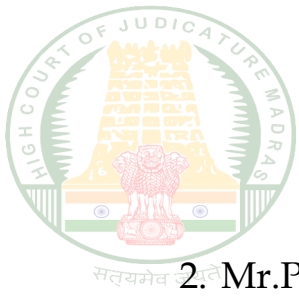
To relax the condition imposed on 06.12.2024 in Crl O.P No. 19473 of 2024 in the bail application, in Crime No. 648/2024

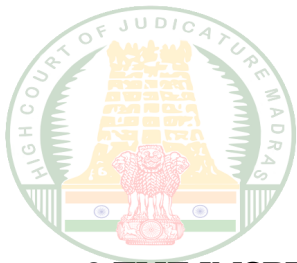
