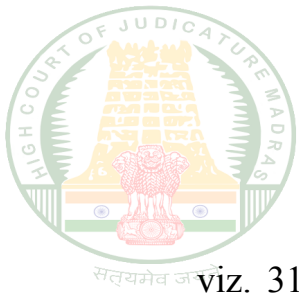

Prayer:- This Writ Petition has been filed, under the Article 226 of the Constitution of India, to issue a Writ of Certiorari and Mandamus, to call for the records relating to the proceedings issued by the 3rd Respondent in Ka.No.005372/351/Ni.Pi.3/D3/2020, dated 10.06.2020 and the consequential proceedings issued by the 2nd Respondent vide Letter No. 043043/1743/F4/F42/2023, dated 16.03.2023 and to quash the same and to direct the Respondents 2 and 3 to sanction forthwith the pension to the Petitioner along with arrears of pension from the date of his retirement,

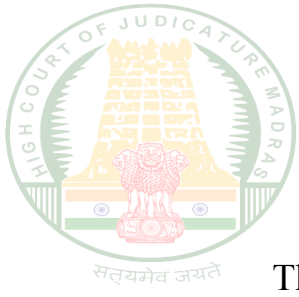
viz. 31.01.2001, by reckoning half of the temporary service rendered by him in the erstwhile Tamil Nadu Electricity Board from 10.12.1983 to 26.09.1991 along with his regular service as per the order issued by the TANGEDCO vide (per) FB TANGEDCO Proceedings NO.31, dated 08.09.2011.

ORDER
