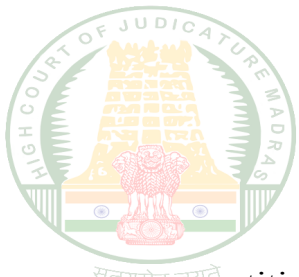

COMMON ORDER

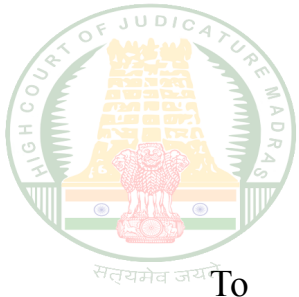
The learned counsel appearing for the petitioner seeks permission of this Court to withdraw these writ petitions and has also made an endorsement in this regard.
