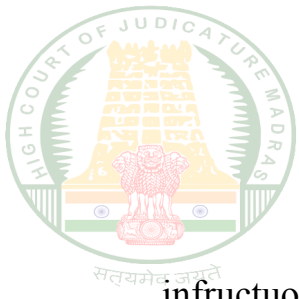
petitioner's representation, dated 25.01.2025 in accordance with law and pass such further or other orders as this Court.

infructuous. During the enquiry, the respondents have not harassed the petitioner.

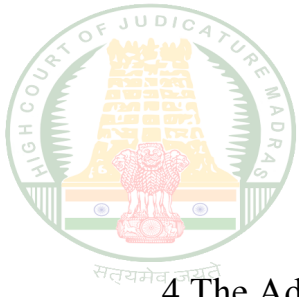
3. Recording the above said submissions of the learned Additional Public Prosecutor for the official respondents, this Criminal Original Petition stands dismissed.
