He further states, his complaint to the police was not entertained, but, subsequently, when a complaint was made to the Commissioner of Police on 03rd January,2025, the alleged

trespasser vacated the premises. Counsel says, as on date, petitioner is in peaceful possession of the property.

Counsel for respondent No.3 – Assistant Commissioner of Police states that respondent No.3 is there to assist the public and, if at all petitioner faces any problem from respondent No.4 or his family members or anyone claiming through him, petitioner is welcome to approach respondent No.3 and respondent No.3 will take all steps in accordance with law and that also very promptly.
