Consequently, connected Miscellaneous Petitions are closed. No costs.

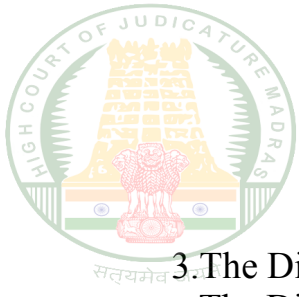
