2. The grievance of the petitioner is that the respondents erected an electric pole in his property, which is causing much disturbance to him. In this regard, the petitioner submitted a representation, dated 12.08.2024, to the respondents to remove the said electric pole. However, no action has been taken by the respondents. Hence, this Writ Petition.

In view of the above facts and circumstances of the case, coupled with the fact that the representation submitted by the petitioner has been pending with the respondents for about six months, the fourth respondent is directed to consider the representation of the petitioner, dated 12.08.2024, and pass appropriate orders on merit and in accordance with law, within a period of two months from the date of receipt of copy of this order.

4. Writ Petition is disposed of accordingly. No costs.
