The case of the petitioner is that he filed an original application vide O.A.No.4 of 2021 before the first respondent, against the encroachment of land by the respondents therein and pending disposal of the said Original Application, the petitioner also filed an interlocutory application, which is unnumbered, seeking injunction. According to the petitioner, the said application is neither numbered nor disposed of and taking advantage of the same, the respondents therein are carrying out illegal activities in the land. Hence, this Writ Petition.
