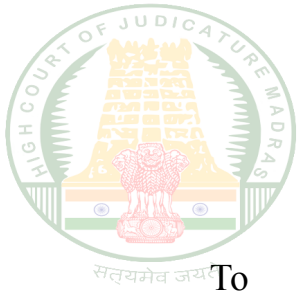
Sections 294(b), 323, 506(1) IPC. Now, they have moved this petition to quash the FIR in Crime No.313 of 2022 registered against them.
