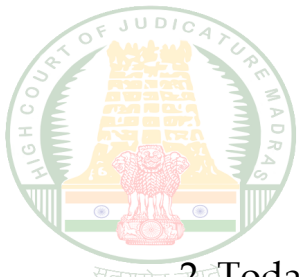
PETITION FOR BAIL Under Sec.483 of BNSS
