ORDER

This Petition has been filed to modify the condition imposed in the order passed by this Court in CrI.O.P(MD). No.961 of 2025, dated 17.01.2025.

2.Mr.R.Sankarakutralingam, learned counsel appearing for the petitioner, submits that the petitioner is studying ITI at Chromepet, Chennai and hence, he is facing some difficulty in complying the condition No.7(b) imposed by this Court in CrI.O.P(MD). No.961 of 2025, dated 17.01.2025. Accordingly, he prays to modify the condition.

3.Mr.K.Sanjai Gandhi, learned Government Advocate (CrI. Side) appearing for the respondent-Police, submits that the petitioner has not complied with the

The other conditions shall hold good.
