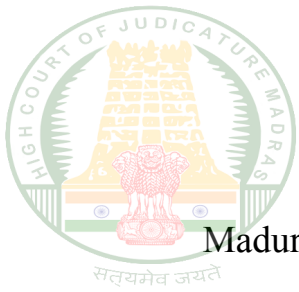

6. With the above said observations and directions, this writ



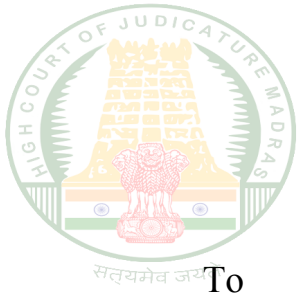
