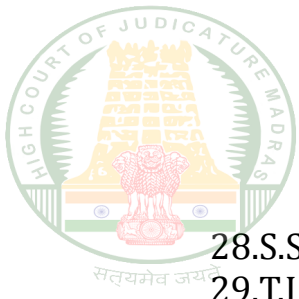

J U D G M E N T

(Order of the Court was delivered by G.R.SWAMINATHAN, J.)

Heard both sides.

2. The appellants herein cleared TET in the year 2013. They sought appointment as Secondary Grade Teachers / B.T.Assistants without being called upon to participate in any competitive examination. The learned single Judge citing the order of the Hon'ble Division Bench dated **10.07.2024** in **W.P.(MD)Nos.26084 of 2023** etc. batch dismissed a similar writ petition. We had also endorsed the stand of the learned single Judge vide order dated **02.06.2025** in **W.A.(MD)Nos.1310 and 1311 of 2025**. We had also pointed out that



the writ petitioners are guilty of laches. In this case also, the writ petitioners have knocked the doors of the Court after a lapse of full ten years.

3. In this view of the matter, interference with the impugned order is not warranted. This writ appeal stands dismissed. No costs.
