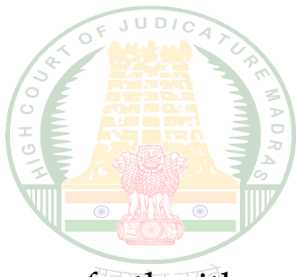
### ORDER
