### **ORDER**

2.It is the grievance of the petitioner that her representation dated 22.01.2025 seeking removal of the encroachment made in the properties belong to her, is kept pending till date without any progress. Therefore, she has filed this Writ Petition, seeking for a direction to the 1<sup>st</sup> respondent to consider her representation.

3.Mr.M.Sarangan, learned Additional Government Pleader, who takes notice on behalf of the respondents, submits that the representation of the petitioner would be considered and appropriate orders would be passed on its own merits within a period that may be stipulated by this Court.

4.Considering the limited scope of the prayer sought for by the petitioner, without expressing any opinion on the merits of the claim made by the petitioner either in the representation or in the affidavit filed in support of this Writ Petition, we direct the respondents to consider the representation of the petitioner dated 22.01.2025, after giving sufficient opportunity of hearing to the parties concerned and pass appropriate orders on merits and in accordance with law within a period of eight [8] weeks from the date of receipt of a copy of this order.

5.With the above direction, this Writ Petition is disposed of. No costs.
