2. When the matter is taken up for hearing today, it is reported that R3 died and so far no steps have been taken.

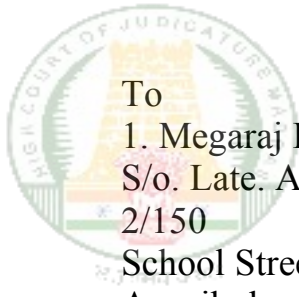
3. Since no steps have been taken and the limitation period has also been over, this petition is dismissed as abated, as against R3.
