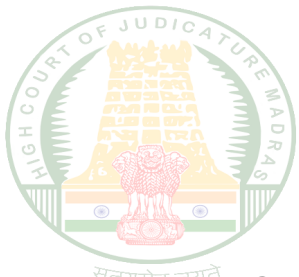

Prayer in CRL OP(MD)No. 720 of 2025:-

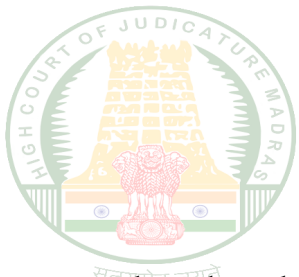
