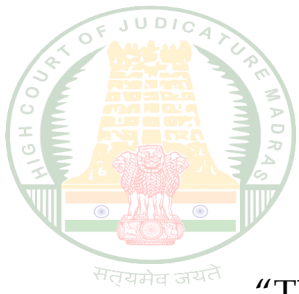
ORDER : The Court made the following order :-

This petition has been filed to modify the condition imposed in Para 5(b) of the said Crl.OP(MD) No. 517/2025 dated, 10.01.2025 in connection with Crime No. 61/2024 on file of the respondent.

2. C. Iyaapparaj, learned counsel appearing for the petitioner submits that the petitioner has been complying with the condition regularly for the past six weeks. He further submits that now, the respondent-police is harassing the petitioner and he prayed for relaxation of the said condition.
