ORDER

This Criminal Original Petition has been filed by the petitioner to expedite the trial in S.C.No.2 of 2024 on the file of the Special Court for trial of cases under SC/ST (PoA) Act, Thoothukudi, Thoothukudi District.

2. According to the petitioner, the petitioner is the third accused in the said main case and the alleged date of occurrence is 03.08.2022 and the case has been pending from 2022 and no trial has been commenced so far. Therefore, the petitioner seeks direction of this Court to speedy disposal of the case.

3. The learned Additional Public Prosecutor appearing for the official respondents would submit that the date of alleged occurrence is 03.08.2022, thereafter, they registered FIR in Crime No.462 of 2022, dated 04.08.2022 and thereafter, they filed charge sheet. The case has been taken on file by the Trial Court in S.C.No.2 of 2024 and now the case is posted for opening the

prosecution. He further submits that they will produce the witnesses without any delay and cooperate for speedy disposal of the case.
