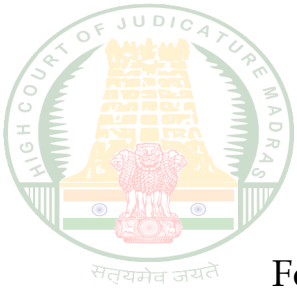

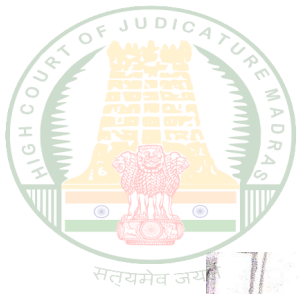
PRAYER :-
