ORDER

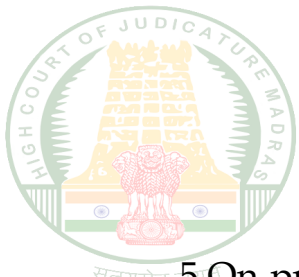
(Order of the Court was made by **J.NISHA BANU, J.**)
