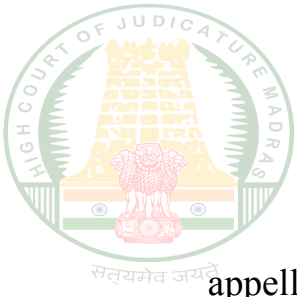
## **ORDER**
