2.Mr.P.Kottaichamy, learned Government Advocate (Crl.side), who takes notice for the first respondent submits that the investigation in Crime No.4 of 2023 has already been completed and final report has also been filed before the Special Court for TNPID Act Cases, Madurai, through e-filing No.LTM20240000045C202500002, on 07.08.2025.

3.Recording the aforesaid submission made by the learned Government Advocate (Crl.side) that the final report has been filed, this court is not inclined to proceed with the first information report alone.
