This petition has been filed by the petitioner to call for the records pertaining to the First Information Report in Crime No.487 of 2024 dated 17.12.2024 on the file of the first respondent police, for the offences under Sections 329(4), 296(b), 115(2), and 351(3) of BNS Act and Section 4 of TN Prohibition of Harassment of Women Act, 2002, and quash the same.

2. When the matter was taken up for hearing, the learned counsel on both sides represented that the matter has been amicably settled between the parties and to that effect, they have entered into a compromise and the same was filed before this Court.

3. The defacto-complainant and the accused are present and this Court enquired about the terms of compromise. The defacto-complainant represented that they entered into a compromise as they are husband and wife and she has no objection to quash the FIR. A compromise memo signed by the parties and their respective counsel, is also filed before this Court.
