WEB COPY This Criminal Original Petition has been filed by the petitioner to direct the respondent herein to file a final report in Crime No.308 of 2022 dated 07.09.2022 for the offence u/s.174 of Cr.P.C. on the file of the respondent.

The learned Counsel appearing for the petitioner would submit that the petitioner is the Defacto-complainant and based upon his complaint the respondent police have registered a case in Crime No.308 of 2022. Thereafter, the respondent police have not conducted proper investigation and they have not filed any final report.
