B) The Hon'ble Court will monitor and surveillance the investigation of Central Bureau of Investigation;

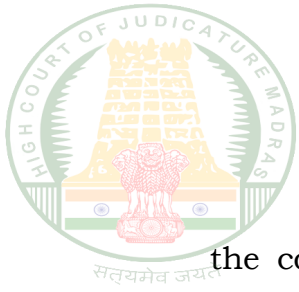

2. In view of the fact that action has already been initiated, no further adjudication is required in this Writ Petition and the same stands closed. There shall be no order as to costs.

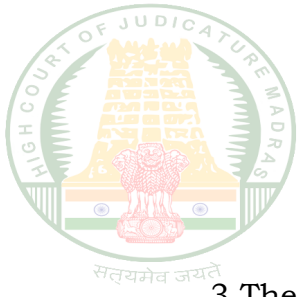
