(Order of the Court was made by the Hon'ble P.VELMURUGAN J.)

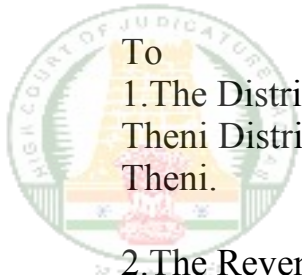
This petition has been filed to condone the delay of 72 days in filing the above review application.
