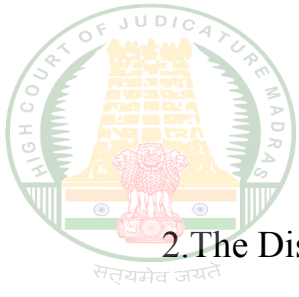

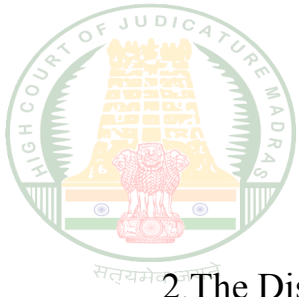
2.Recording the stand of the learned Additional Government Pleader, this Writ Petition is disposed of. There shall be no order as to costs.
