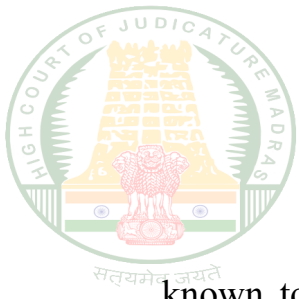

ORDER

This Criminal Original Petition has been filed by the petitioners to call for the records pertaining to the First Information Report in Crime No.19 of 2025, dated 18.01.2025 for the offences under Sections 296(b), 115(2), 118(1) and 351(3) of the Bharatiya Nyaya Sanhita, 2023 on the file of the first respondent police and quash the same.
