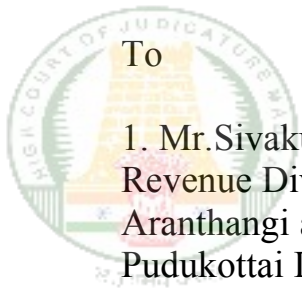
3. Recording the said submission, this Contempt Petition is closed. The personal appearance of the contemnors is dispensed with.
