ORDER

2. With the consent of the parties, the writ petition itself is taken up for final disposal at the admission stage.

3. I have heard the learned counsel appearing for the petitioner and Mrs.K.Malathi, learned Additional Government Pleader appearing for the respondents.

4. The petitioner has made a representation on 17.12.2024 and claims right under the Will executed by Seethalakshmi in her favour. According to the petitioner, the said Seethalakshmi, the testatrix died on

6. Recording the said submission of the learned Additional Government Pleader, the writ petition is disposed of directing the second respondent to pass final orders on the petitioner's application within a period of twelve weeks from 27.02.2025. No costs.
